AFTER SCHOOL PROGRAM (ASP)

ASP is free childcare provided daily by SFCS staff on campus immediately following each school day. Snacks are provided at ASP. There is no bus transportation after ASP. Students in ASP must be picked up on campus by 6PM Monday through Thursday and 5PM on Friday.

COLTS CAMP

Colts Camp is a new childcare program offered on most non-school days (excluding state holidays) during the school year from 8AM-5PM on campus. Breakfast, lunch, and snacks are provided at Colts Camp. A list of Colts Camp dates will be confirmed with families shortly. Transportation may be provided, depending on need. Please help us with planning by noting below if your child(ren) will be attending Colts Camp this year.

- Both programs are FREE to all families.
- If a child is picked up after closing, a \$10 fee will be charged for the first 10 minutes. After 10 minutes the charge will be \$2 per minute. This fee pays for the staff member that must stay with your child. The school reserves the right to exclude families from ASP or Colts Camp for failure to pick up children by closing time on three or more occasions.
- Your child(ren)'s required registration form must be completed and returned to the school to participate.
- Disruptive and disrespectful student behavior will not be tolerated and may result in dismissal from ASP or Colts Camp.
